Taxation service ensures property taxes are properly billed, effectively collected, and that customers receive timely and accurate information on property tax matters.




#### Key service results

The Taxation service's key service results for 2024 were:

- There were almost 570,000 2024 property tax bills mailed for a total of \$3.26 billion in budgeted property tax revenue. The City of Calgary portion of that makes up approximately 43 per cent of its total revenue.
- Tax Instalment Payment Plan (TIPP) participation has increased to over 318,000 active TIPP accounts and approximately \$171 million in monthly revenue. Taxation monthly customer satisfaction scores did not drop below 84 per cent and customer service-related improvements continue to be made with the TIPP online project, providing copies online of property tax bills and school support declarations, etc.
- Staff compassionately worked with the 4,943 accounts identified for warning of tax recovery and just two of those were sold at the Real Estate Public Auction. Approximately 8.9 per cent of billable accounts had a property tax penalty applied on 2024 July 1 which was similar to the previous year. 2024's year-to-date discretionary tax relief programs resulted in \$2.36 million in tax cancellations to affordable housing and senior's organizations, compassionate penalty relief, and the Property Tax Assistance Program.




#### Story behind the numbers

**Status** 



While the Tax Instalment Payment Plan (TIPP) participation rate has remained relatively steady for several years, it has done so while The City has seen a steadily increasing number of total property tax accounts. As of the end of 2024 June, over 318,000 accounts participated in The City of Calgary's TIPP and the resultant TIPP participation rate is one of the highest in Canada with the goal of continuing to be so. Recent improvements such as the TIPP Self Service Registration project will help achieve that goal.





This performance measure is a key factor in increasing customer satisfaction and public trust in the Taxation service. Results are commonly at or near 100 per cent but occasionally unexpected events push results lower than desired levels. The first five months of 2024 have seen every month at higher than 99 per cent except January at 97 per cent when call volumes were higher and staffing levels were lower. Efforts to improve forecasting continue so that staffing levels can be high enough to deal with unexpectedly high call volumes.

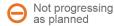





## Operating Budget Updates - 2024 YTD net operating budget vs actuals:

Taxation has a favourable operating variance of \$0.2 million. The main reasons that have contributed to the variance are higher than anticipated revenues from City Online (e-commerce) as a result of increased real estate activities of \$0.8 million, partially offset by unfavourable variances of (\$0.2) million from higher contract & general services expenses, (\$0.2) million from the Property Tax Assistance Program (PTAP) caused by timing differences, (\$0.1) million from higher than budgeted salary & wages expenses, and (\$0.1) million from other small variances.

As of June 2024, Taxation:

- Mailed a property tax notice to almost 570,000 accounts for a total of \$3.3 billion in budgeted property tax revenue.
- Have around 318,000 active Tax Instalment Payment Plan (TIPP) accounts.
- Maintained an effective property tax collection process with only two properties being sold at the 2024 Real Estate Public Auction despite second highest number of accounts identified for warning of tax recovery in Calgary's history.
- Provided around \$2.4 million in discretionary tax relief to non-profit organizations and citizens in need.
- Created the Customer Solutions section.
- Caught up on Service Requests after a dip in performance in late 2023 due to high volume and low staffing.
- Brought the Delegated Tax Cancellation Authority
   Bylaw and Council Policy to Council where it was approved on 2024 June 4.

# Capital Budget Updates - 2024 total capital budget vs 2024 YTD spend:

Taxation has spent 46.2 per cent of the 2024 approved capital budget.

In 2024, the capital expenditures have been used to deliver progress towards two main capital priorities.

The first is the City Ownership Online Upgrade (COOL) Update, which interfaces with Alberta Land Titles and allows The City of Calgary to receive feeds of ownership changes. This project has now been divided into two phases. Phase 1 is the bulk of the COOL and Property Ownership Web Service (POWS) stream and is approximately 75 per cent complete, with the balance is due to be finished in Q2 2025. Phase 2 is the Land Titles Information Application (LTIAR) stream, which is 25 per cent complete, with the balance due to be finished in Q3 2025. POWS and LTIAR are integral to COOL's function; therefore they also need upgrading. There is a Project Change Request for an additional capital expenditure of \$457,000 to be presented at the September 2024 Corporate Technology Committee (CTC) meeting. The original estimate of \$2.4 million was previously approved by CTC; the original budget was \$3 million.

The second is the PTWeb Update, which is the primary property tax system. This project only began in Q1 2024, predominantly due to constraints in resource availability, and is currently on track with an options analysis. A survey has been sent to other municipalities and team members are reviewing feedback for further follow-up. Preliminary work is being done to draft high level requirements using work done on a separate project to document workflows for the different Taxation teams.
