Description of fund:

The 2025 Non-profit Affordability Support Fund provides one-time financial assistance to non-profit organizations that receive funding from the City of Calgary for social programs. By covering eligible operating expenses unmet by existing resources, this fund helps organizations maintain stability and continue delivering vital services to Calgarians experiencing vulnerabilities. Up to \$6 million will be available through this fund in 2025.

Funds granted to successful recipients must be utilized by December 31, 2025.

In addition to this application, you must upload your organization's most recent [provincial](#) or [federal](#) annual return (including financial statement) OR your most recent audited organizational financial statement. This can be done in the Documents section of FIMS.
